Official rules and guidelines of the 2019 CVGT Talent Auditions

- A completed Chula Vista’s Got Talent application and a \$25 fee (payable by cash or credit card) must be submitted by May 25th. No late applications will be accepted.
- A Chula Vista’s Got Talent Waiver and Release Form must be signed and submitted along with application.
- Auditions must be appropriate for all ages of the audience. We ask for clean music lyrics along with appropriate gestures, attire, materials, and props.
- Auditions are allowed a 2-minute time frame which is to not be exceeded.
- Participants must provide own technical equipment and props if needed. An amplifier and microphone will be available for use.
- Winner’s evaluations will be based on opinion and appeal of judges. All decisions are final.
- Additional information concerning the location and times of auditions will be sent to all applicants via email after May 25th.

Note: Only one application is needed per audition. Auditions consisting of 2 or more participants will need to fill out individual safety waivers per participant. Additional auditions by the same participant(s) performing a different styled act are allowed with a separate CVGT application submission and \$25 fee. (If you have multiple talents, we want to see them!)

Chula Vista's Got Talent Waiver and Release Form

I hereby acknowledge and agree that I am voluntarily participating in the Chula Vista's Got Talent Competition. I understand that participation may include dancing or other activities which may be inherently dangerous and may cause serious or grievous injuries, including bodily injury, damage to personal property and/or death.
